In this issue, Main Street Nevada (MSN) is pleased to showcase the successful grant efforts in our community.

In just over two years, Main Street Nevada has been fortunate in their grant applications. This assistance has helped building owners receive over \$500,000 in grant funding. This has leveraged over \$2 million of committed building improvements and investments in the district. To start this process, oftentimes building owners reach out to MSN to help create a vision. Then a visual rendering of their building is requested.

A service of Main Street Iowa (MSI) to MSN is the "design assistance program." MSI has on staff design professionals who visit the building, view historic photos and plans to create renderings of what it could look like. This rendering is useful not only to the building owner but to assist in future grant writing processes.

These renderings are provided from MSI as one of the services provided to our community. Since becoming a MSI community in 2019, MSN has received six renderings and has another four currently underway.

The cover of this edition is the rendering for the FarmGrounds' building, known as the Boyd and Child Block. Historically the building rendering is focused on opening the storefronts and bringing back a representation of their original appearance. Design professionals from MSI visited Nevada to meet one on one with the property owner to talk about the use of the building and future plans for the space. MSI design assistance can range from full building renderings to smaller projects, such as the floor tile patterns in Bricktown Bakery.



# NEDC recognizes investors during Annual Breakfast



## Understanding the County's Floodplain Management Program



For unincorporated areas of Story County (outside city limits), Story County has a floodplain management program in place which focuses on three aspects — Regulations, Mapping, and Flood Insurance. More details on each of these components may be found on the Story County website at [www.storycountyia.gov](http://www.storycountyia.gov).

When flooding occurs, the flood waters don't stop flowing when they hit a city/county boundary. Floodplain maps, developed through the National Flood Insurance Program, recognize this. While individual jurisdictions have authority over areas within their boundaries, the same maps and information are used to inform decision-makers.

If you want to find out if your property is located in the "Special Flood Hazard Area," which is the official name of the floodplain, below are some tools to help you.

- To look at your property and determine whether it is in the Special Flood Hazard Area, visit the Story County Assessor's website at: [www.storyassessor.org](http://www.storyassessor.org). Enter your

address in the search box, and once the report comes up showing your property, click on the "Map" icon in the upper left corner and turn on "FEMA Flood Data" in the legend.

- Another great resource to find an official flood map, access flood hazard products and understand flood risk is FEMA's Flood Map Service Center at: <https://msc.fema.gov/portal/home>. On this site, you can search by address and use other tools to find your property.

Real-time flood information is provided by the stream and river sensors installed across the state of Iowa. If you're tracking progress of floodwaters, visit the Iowa Flood center IFIS tool at: <http://ifis.iowafloodcenter.org/ifis/>. Iowa State University Extension and Outreach has compiled a "Flooding in Iowa" video series to educate local officials and the general public about floodplains, flood risks, and basic floodplain management principles available online at <http://www.extension.iastate.edu/floodinginiowa>.

# Clintons named Story County Citizens of the

The Story County Citizen of the Year Award is given annually to residents of Story County who perform meritorious service above and beyond what would be expected of a citizen. Their efforts demonstrate creativity, vision, leadership, and citizenship by providing service to programs and activities that positively impact the welfare of the citizens of Story County. This extraordinary service is either through their regular vocation or in the community, or a combination of both.

Faces familiar throughout Story County — Edna Young Clinton and Wayne E. Clinton — were recognized by the Board of Supervisors as the 2022 Citizens of the Year.

Edna Clinton, as a resident of Ames for more than 50 years, has been a champion for civil rights, education, criminal justice reform and ensuring access to medical and mental health services. She served as president of the Ames Branch of the NAACP as well as many other roles. She has worked closely with local law enforcement agencies, providing trainings and moderating countless important conversations. Her passion to get information into the hands of those who need it has brought about initiatives and programs, like Taking the Lead 2021, that are still impacting our community today.

Wayne Clinton served as a Story County Supervisor for 16 years, leading the County as Chair several years during his tenure. In 2017, he was recognized with the Golden Eagle award from the Iowa State Association of Counties for his extraordinary public service to county government through the state and national associations. In addition to his time on the Board of Supervisors, Clinton taught and coached for more than 40 years in the Ames Community School District. He served as a long-time collegiate basketball official on the college level and officiated football as well. His life-long dedication to public service goes beyond these successful endeavors to his involvement in organizations throughout the community. He bravely shares the experiences he has had throughout his life both in and outside of Story County.

## FREE MEALS END NEXT YEAR

When the 21/22 school year ends, so will free meals for every student. While the federal government funded a program that allowed all students access to free meals during the COVID-19 pandemic, Congress recently declined to continue funding this program. This means all families will need to carry a positive balance in their student's meal account when school begins next fall if they plan to eat school meals.

We understand this change may cause you to worry. There are important steps you can take today to make sure your student receives the meals they need next year.

- Budget for the cost of school meals (if your student does not qualify for free meals)
- Deposit money into your student's meal account
- Families that do not qualify for free meals can start depositing money into their lunch accounts through our payment system,

RevTrak ([nevadacubs.revtrak.net](https://nevadacubs.revtrak.net)) to prepare for the cost of school meals next year

- Complete an application for free and reduced meals (if you feel you meet the income guidelines and do not currently qualify)

If you complete the online free and reduced application before July 1st and qualify for free or reduced meals, you are given a 30-day grace period at the start of the 2022-2023 school year to complete another application for next year - but will need to fill out the application again for the 2022-2023 school year.

The 2022-2023 school year application will be available on the District's website after July 1, 2022 to complete.

As a reminder, even if you've filled out the application in the past, you will need to fill it out again as it's required to be filled out each year.

## NEVADA FFA GREENHOUSE SALES SET NEW RECORD

Nevada FFA greenhouse plant sales totaled \$7,746 this year, surpassing the 2021 sale by over \$1,700! Total wholesale and input cost for the spring greenhouse crop totaled \$3,333, therefore providing the chapter with a \$4,413 profit. Nevada FFA had Saturday sales in April & May this year. "I really have to give credit to the students that took ownership of the planning, production, and did a great job of taking care of customers!" mentioned Kevin Cooper, Agriculture Education instructor & FFA Advisor. The next greenhouse crop will be mums in the fall. Watermelons have already started growing in the greenhouse and then will be planted in the field. The watermelon will be used in the school lunch program next fall.

# Quality Care for 25 Years

When deciding where he would establish his first primary care practice, Adrian Palar, MD, made visits to prospective clinics across the United States. Living in California at the time, he and his wife narrowed the choices down to four and put the names in a hat.

The name pulled out of the hat that day was Nevada, Iowa. Now, more than 25 years later, Dr. Palar says it is home.

"I feel it was God's blessing that we ended up here," he says. "This quickly became home for us. Everyone was so welcoming. I am happy to still be providing care for patients here."

While Dr. Palar is the longest tenured Story Medical Clinic employee, Elaine Pratt has been there nearly as long. She started as a receptionist just a couple days after Dr. Palar, quickly realizing that she loved the work.

"I knew the manager at the time and she asked me if I would be interested in a part-time position," Pratt says. "I took it and worked my way up to full-time and I'm still here. I love it. This is where my heart is."

Together, the duo has seen a number of changes, most notable the introduction of electronic medical records. At the core, however, Dr. Palar as a provider and Pratt who today is a Patient Services Representative, remain as focused as ever on one priority: the patient.

"I like being in a small town practice," Dr. Palar says. "Here we get to know people as more than just our patients. We live in the community, we work in the community, and we get the opportunity to care for those in the community. I love it here."

# Sports Physicals Offered Free

With the aim of ensuring the state's junior high and high schoolers are healthy enough to hit the field (or court, pool, course, etc.), the state requires sports physicals to be completed before athletes are cleared for competition on school-affiliated teams.

Story Medical Clinics are proactive in promoting these sports physicals and are offering them free from 2:30 to 5 p.m. on Wednesday, July 20 at the Nevada and Maxwell Clinics, and Monday, August 1 at the Nevada Clinic only. The free sports physicals are open to all area school-aged athletes. No appointment is necessary.

Attendees should download the physical form required by the state athletic associations at [www.storymedical.org/sportsphysical](http://www.storymedical.org/sportsphysical)

and bring it with them. The team at Story Medical Clinic will complete the form at the appointment.

To compete on a school-sponsored team, the form must be completed and signed by a licensed physician, osteopathic physician, osteopath, advanced registered nurse practitioner (ARNP), physician assistant or qualified doctor of chiropractic, stating the student-athlete may safely engage in athletic competition. The form must be completed annually.

The Main Street Nevada Design Committee undertook a facade improvement project on its own building last summer to demonstrate what a small facade project entails, and to help train the committee in facade improvement techniques.

## Improving Facades

Just under a year ago, the Main Street Nevada Design Committee began planning a Micro Facade Grant program for the district. These grants were not meant to fund a full building renovation, but to help with small building projects. Main Street Nevada's grant was made possible due to a generous donor, who wanted to give back to their neighboring Main Street businesses. The Design Committee worked for several months to create the program, researching other similar grant programs from Main Streets across the nation.

Brooke Hartman, Chair of the Design Committee said, "Part of the Design Committee's purpose is to encourage improvement and help maintain the physical appearance of the Main

Street District. Our dedicated members are passionate about preserving historic buildings while helping our community thrive. To achieve this, we set a goal to create a program to help our Main Street building owners accomplish their facade projects. With the support of generous investors and their donations, the committee was able to make this goal a reality, and the Building Façade Grant was created."

This year's awardees are the American Legion and Blue Moon Properties. The American Legion will use its grant funds for the facade of the American Legion Post building at 1331 6th Street. Blue Moon Properties will work on the facade of the Story Hotel Building at 937 6th Street. The funds

will help finance tuckpointing work, entryway renovations, door replacements, basically anything that better seals a building's exterior.

The two awardees were selected based on their commitment to conduct work that will follow historic design standards, and their ability to complete the work in a designated timeframe.

The Facade Micro Grant is planned to become an annual offering to building owners in the Main Street District. # Prepare to celebrate the 4th of July

The Nevada American Legion invites the public to take part in Nevada's 4th of July activities on Monday, July 4.

A parade begins at 10 a.m. The parade route is on 6th Street, starting at E Avenue and going north to N Avenue. Those wishing to be in the parade can gather along E Avenue, between 7th and 9th streets starting at 9:15 a.m. There is no fee to be in the parade, however everyone must fill out a liability waiver prior to the start of the parade. Immediately following the parade, the Annual Chicken & Noodle Dinner will be served at the American Legion dining hall, 1331 6th St. Cost of the dinner is \$10 per person (\$5 for kids age 10 and under). # What you need to know about the new wastewater facility & utility rates

While wastewater is not something many of us think about on a daily basis, it is something we utilize on a daily basis. Because of this we must move forward with the needs of our community.

The existing wastewater treatment facility has served Nevada residents for approximately 60 years and is at the end of its life. It does not have sufficient capacity for planned industry expansion and projected population growth. It is also unable to provide the additional effluent disinfection and nutrient removal requirements mandated by the Iowa Department of Natural Resources (IDNR). Mandates from the IDNR are happening in cities across the state as permit renewals come due. Much of the equipment at the current facility has been in use longer than its life cycle, and despite repairs and attempts to keep the existing plant functioning longer, it simply cannot keep up with future demands.


Because of this, the new wastewater treatment facility (*construction pictured at the top of this page*) is in the process of being built three miles south of Nevada. Based on estimated costs of construction and operation, a rate analysis was performed by the City's financial advisor. The City will be utilizing the State Revolving Fund (SRF) program, using loans that must be repaid by sewer revenues.

In order to provide enough revenue to pay off the debt incurred, user rate increases are necessary.

Your monthly utility bill covers both water charges and

sewer charges. On the sewer side of your bill, current increases are happening, in large part, because the City of Nevada is building and must pay for this new \$60 million wastewater treatment facility. We could see several more increases this year and in coming years as City Council members and the City's bonding expert determine how much revenue is needed to fund this new facility.

The first increase, as voted by the City Council with Ordinance No. 1022, went into effect April 1, 2022.



That Ordinance, as the City shared on its website newsreel in February, increases the minimum sewer use charge from \$12.16 to \$20.00 and the Sewer Construction Charge from \$2.44 to \$5.00. On your bill the minimum charge is added to your usage charge and listed as Sewer O&M (minimum charge + usage charge). The Sewer Construction Charge (\$5.00) is listed separately as "Sewer Cons" on the bill.

The next increase on utility bills will be the annual 3 percent increase to water, which will be reflected on your July 1 utility bill.

If you have any questions/concerns, please reach out to our City Hall staff, 515-382-5466, or stop by City Hall and we can walk you through a handout, so you can gain a clearer understanding. We also have a list of local resources that might be able to help those who qualify for assistance to help pay their utility bill.





# Nevada PD wants all riders to ride safely

## BICYCLE SAFETY TIPS

With the weather becoming warmer and more people out and about, the Nevada Public Safety Department would like to remind everyone of a few safety tips when out riding your bike.

- In warmer weather, you can easily forget to hydrate. Make sure before you do any exercise like bike riding, you hydrate. Drinking water is the best thing you can do to stay hydrated.
- Wear light, loose clothing when riding your bike, this will reflect the sun's heat and the light weight of the clothing will help regulate your body temperature.
- Make sure your tires are properly inflated, your brakes work and your chains are tight and have proper lubrication. Any deficiencies with your bike can lead to possible injury.
- If you ride in the roadway with traffic, follow all traffic laws. Do not ride your bike *against* traffic, ride *with* traffic.
- Make sure to wear a bike helmet, gloves, eye protection, and any other protective gear you see fit to put on before you ride your bike.
- If you ride your bike at night, be sure to wear reflective clothing or light-colored clothing. Do not wear dark clothing. Wearing dark clothing will make it very difficult for drivers to see you.
- If you ride on the street at night, make sure to have a white light to the front, and a red light or reflector to the rear. If drivers can see you better at night, it will reduce your likelihood of crash or injury.

### LICENSE YOUR BICYCLE

Go to the City of Nevada Website to obtain a bicycle license. You'll find a form for this by clicking on the Police Department page and then clicking the Quick Link for bicycle license.

This license will help police officers in returning your

bike to you if it becomes stolen or lost. Best of all, it's FREE to license your bike with the Nevada PD.

### DON'T RIDE ON MAIN STREET

Due to higher traffic volume and the constant "backing out" of vehicles from parking spaces, City Code prohibits the public from riding bikes on 6th Street between I Avenue and M Avenue (the main downtown district).
